#### Proposal for Distribution of Proposition 172 Funds To Yolo County Rural Fire Districts

#### I. History

On November 2, 1993, California voters enacted Proposition 172, which established a permanent statewide half-cent sales tax for support of local public safety functions in cities and counties. Proposition 172 was placed on the ballot by the Legislature and the Governor to partially replace the \$.2.6 billion in property taxes shifted from local agencies to local school districts as part of the 1993-94 state budget agreement.

While Yolo County has been receiving monies from the approval of Proposition 172, no funding has ever been allocated to any of the 15 rural fire districts serving Yolo County. The Yolo County Fire Chief's Association, after gaining agreement from all 15 rural fire districts' Boards of Commissioners, has requested that Yolo County include the 15 rural fire districts' in the annual appropriation of monies received under Proposition 172.

Yolo County is willing to consider allocating funds to Yolo County rural fire districts but has requested a plan on how the rural fire districts propose distribution and use of the funding.

#### II. Purpose

The purpose of this proposal is to propose a funding model for the distribution and use of Proposition 172 funds to the 15 rural Yolo County fire districts.

Rural Yolo County fire protection is primarily provided by 15 fire districts. Four of the 15 districts contract with city fire departments to provide service. The other 11 fire districts are considered "volunteer" fire departments. Five of the 11 volunteer fire departments also have some paid staff.

Most of rural Yolo County relies on volunteer firefighters to responded and fulfill the critical role of first responders. Rural fire districts are faced with dwindling volunteer numbers and the rising cost of equipment needed to provide services. The Yolo County rural fire districts need funding in order to resolve these issues. The allocation of Proposition 172 funds to the 15 rural Yolo County fire districts will enable each district to improve staffing, training, and the purchase of equipment.

#### III. Proposed Allocation Strategy

Currently the Yolo County Board of Supervisors' allocates annual Proposition 172 funds as follows:

- 60% to the Yolo County Sheriff's Office
- 20% to the Yolo County District Attorney
- 20% to the Yolo County Probation Department

The following proposed strategy would provide funding to the Yolo County Fire Districts while gradually reducing funding to the other three departments listed above:

### IV. Funding Distribution Model

The following is a distribution model for the total allocation of Proposition 172 funds received from Yolo County. Please refer to the attached distribution example.

- Equal Distribution 70% of the total funds received will be evenly divided between the 15 rural fire districts.
- **Call Volume** 15% of the total funds received will be based on the average of a district's 3-year call volume. Each district's call volume percentage will be calculated by dividing the district's 3-year call volume against the total 3-year call volume of all 15 rural fire districts. Using a 3-year call volume average, fluctuations based on irregular circumstances are more balanced.
- **District Population** 15% of the total funds received will be based on each district's population. Each district's population will be calculated by dividing the district's population against the total population of all 15 rural fire districts. (*The data used in the attached funding example was compiled from 2016 LAFCO MSR report.*)

#### V. Accountability

To ensure Proposition 172 funds are used appropriately, a district must develop and submit to Yolo County's CAO for approval, an <u>Improvement Plan</u>, based on their unique needs and requirements. The plan must strive to meet the NFPA 1720 standards, detail how funds will be spent and an evaluation process.

#### VI. Review Process

Yolo County's CAO's office will establish timeline(s) to:

- **Update** each fire district's call volumes and population in order to ensure that monies are being allocated appropriately.
- **Evaluate** each district's Improvement Plan progress.

1. Call the meeting to order

The meeting was called to order by Chairperson Guarino. Present were:

- 3. <u>Discussion/Action</u>
  - a. <u>Review Current Budget Usage FYE June 30, 2021 (All)</u>

Chief Rita presented and reviewed numbers as of December 31, 2020.

b. Projected Budget Usage - Remainder of FYE June 30, 2021 (Chief Rita)

Estimated salaries and benefits (without added benefits) anticipates budget use approximately \$11,000 under projected. It is harder, at this point in the budge cycle to estimate services and supplies use, but it is anticipated that we will again come in well under budgeted amounts in those funds, as well.

c. Projections for FYE June 30, 2022 Budget (Chief Rita)

Chief Rita anticipates that we will not suffer a decrease in revenues from property taxes mainly due to the recent passage of Proposition 19 in California.

### d. <u>Discussion/Action - Recommendation to Board for Additional Career Staff</u> <u>Benefits (Chief Rita)</u>

We are one of the few districts with career staff that does not offer benefits for medical and/or retirement. We have been coming in under projected budget for years. Chief Rita believes we can offer additional benefits and still have monies to budget for apparatus replacement and facilities improvements.

The discussion started off with Chief Rita recommending a minimum of \$250 per month per career staff. \$250 per month for full-time career staff would be an additional \$9,000 per year; for all career staff (full- and part-time), \$12,000. AC Heins would prefer that we not include the part-time career staff and instead use those funds to increase the monthly from \$250 to \$335 per full-time career staff member (total \$12,060). Part-time career staff could be included later, as appropriate and/or negotiated.

AC Heins reported that each of our career staff had different needs. Chief Rita suggested that a cafeteria type plan might be a better option, offering health care premium, health savings account, dental, and retirement options.

By consensus, Commissioners Guarino and Hjerpe directed that:

- The committee recommend to the Board that the District offer, as a new benefit to full-time career staff, a cafeteria plan with health insurance premium, health savings account, dental, and retirement options
- The committee recommend to the Board that benefit amount be set at \$335 per month
- Chief Rita and AC Heins explore what we need to do to put such a cafeteria plan in place, how it would work, etc. and report back







### 3) OLD BUSINESS

a) Update – Forced Abatements

i) APN 037-110-005 - 26960 County Road 96

AC Heins had a discussion with the head of maintenance for the Davis Joint Unified School District. After discussing the process and the additional costs associated with the administration of forced abatement, the head of maintenance decided she would much rather have them do the work themselves. The head of maintenance is now in the process of obtaining bids for the work to be completed. AC Heins suggests the Board allow the school district a few weeks to get that accomplished. If abatement is not completed, then the board can bring the forced abatement to the next meeting.

### b) Update – Weed Abatement (AC Heins)

AC Heins stated that of the properties originally identified as being deficient in their weed abatement, several have made enough progress that the district no longer needs to pursue forced weed abatement. However, there have been additional properties that have been identified that continue to be deficient in their weed abatement. AC Heins stated an update will come to the board at the next meeting if regarding those that have not completed their abatement.

Commissioner Yeager stated his concern is that these properties that have not completed their weed abatement will not get done until next year since the rainy season is near. AC Heins stated that, weed abatement is a year-round process. He recognizes that just because there has been one rainfall, does not mean that the vegetation management in the district isn't continuing to be a problem. The district will continue to enforce abatement as appropriate.

Commissioner McMullen asked how the district will get the job done and the vegetation managed before the next fire season, unlike this year. AC Heins stated that due to inconsistent staffing for the past 3 years the weed abatement has not been consistent. Now that this year there has been consistent staffing the weed abatement was not achieved until halfway through the season. AC Heins also stated that because of Chief Rita's rewrites of the letters and cards sent out to residents, the district now has a hard start date. Additionally, the district now has the ability to utilize volunteers to make initial inspections much timelier. Finally, he estimates by the end of April or beginning of May, the district should have identified the properties with issues and for the process to be much more streamlined.

Commissioner Hjerpe suggests there be consequences to the properties who are deficient in their weed abatement. AC Heins also agrees and noted that there is a process the district goes through to make a correction prior to forced abatement.

Commissioner Yeager suggests starting next year with the properties who have not been committed to the program first. AC Heins agrees with Commissioner Yeager's suggestion.

c) Update - W230 Replacement (Chief Rita)

Chief Rita requested AC Stiles give the update instead. AC Stiles stated he traveled to South Dakota last month for a final inspection on W230. Some issues were found but have since then been corrected prior to delivery. W230 was delivered December 11 and picked up and taken to Chief Stiles' shop for final equipment installation. W230 should be in service towards the end of December.

### 4) LILLARD HALL

a) Manager Report (Manager Sinclair)

Manager Sinclair is currently in the process for collecting bids to repair hall doors. After talking to a locksmith, it was discovered that the hall doors need to be replaced due to out of date door hardware. She is now collecting bids on replacing the hall doors from door companies. Manager Sinclair also stated she is collecting bids from tree trimming companies to have the trees outside the hall pruned.

### 5) NEW BUSINESS

a) Discussion / Action – Out of District Volunteer Applications (AC Heins)

AC Heins stated that at this time there are no out of district applicants.

b) Discussion/Action – Support for County Sales Tax Ballot Initiative (Chief Rita)

Chief Rita stated that since the last meeting the county has not put out a plan regarding use of funds that would be collected if a ballot initiative were put to a vote and passed; there is not much more to update at this meeting. She also stated the AC Stiles, who is a member of the committee, attended a recent committee meeting and suggested he give the board an update based on that meeting.

AC Stiles stated that nothing was decided in the meeting and they plan to meet again in January with county representatives. He stated that the county's goal is to have a plan finalized in January, out to the county chiefs by February, to the boards of each fire district by February or March, and to the board of supervisors by April.

Commissioner Yeager's concern is who is going to vote on this tax. AC Stiles stated that the intent of the tax is to collect a ½ cent tax on rural sales. It will not be applied to anything sold within the incorporated areas. It will be voted on in unincorporated areas.
